Player eligibility is completed in the computer program – unregistered players cannot obtain eligibility

☐Game are 2 x 20 minutes running clock

☐The game clock will start at the scheduled time

☐Teams can start the game with four (4) registered players in uniform on the court

☐A player must play 45% of the scheduled games to be eligible to play in the final series

☐Player (s) must sign the "sign on" sheet and put their playing number beside their name on the Score sheet

☐If you print your name on the scoresheet after your first game – check with the Court Supervisor

☐All players and officials are required to vacate the court/bench area after the game is completed

☐Disputes should be directed to the Court Supervisor or Referee Supervisor
